XIII International Pushchino Symposium on Evolutionary Economics "Evolution of Hierarchical Economic Structures and Economic Growth", Russia, Moscow Region, September 6-7, 2019

Call for Papers

The XIII International Pushchino symposium continues a series of biennial symposia held in post-soviet Russia since 1994, to discuss the challenges of evolutionary and institutional economic theory. Pushchino Symposia are the leading Russian scientific platform for domestic and foreign scholars to present interdisciplinary and heterodox approaches to the study of the economy.

In 2019 the Pushchino symposium focuses on the consideration of the complex structure of the modern economy, which must be taken into account when studying the patterns and characteristics of economic growth. Does the development of networks, horizontal and similar structures in the era of the third and fourth industrial revolutions mean erosion of traditional hierarchies in the national and global economies? Or is it about reconfiguration and increasing complications of the hierarchy of economic structures? And how are these structural changes related to economic growth?

The symposium welcomes contributions that address the issues below, as well as other relevant topics:

- Methodology and new theoretical approaches for the study of a modern complex economy
- Architectonics of a modern economy: hierarchies, networks, heterarchies, rhizomes?
- Limitations of neoclassical economic theory and the potential of heterodox economics (including approaches based on Marx, Schumpeter, Polanyi and others) to understand the modern economy
- Interdisciplinary approaches including systemic, synergetic, evolutionary and others
- Meso-level analysis in economic theory
- Third and Fourth Industrial Revolutions: challenges for economic analysis
- Economic growth of a complex economy
- Monetary policy, financial stability and economic growth
- Trends in the development of the monetary system: centralization or decentralization?
- Meso-analysis of economic reproduction

Also, during the symposium, it is planned to hold a round table discussion on the "Theoretical foundations of economic reforms in Russia, China and India: a comparative analysis"

Working languages are Russian and English (simultaneous translation will be available).

The symposium will be held by the Centre for Evolutionary Economics in collaboration with institutes of the Russian Academy of Sciences namely the Institute of Economics and the Central Economics and Mathematics Institute, with the support of the Russian Foundation for Basic Research. International coorganizers are China Society of History of Marxist Philosophy (Beijing, People's Republic of China) and Zaheer Science Foundation (New-Delhi, India).

Submissions will be evaluated by a Programming Committee whose Chair is Academician of the Russian Academy of Sciences Vladimir Maevsky.

Abstracts of the symposium will be published in Russian and English. A selection of the final papers will be published in a collective monograph continuing a series of Pushchino symposia proceedings which have being published since 1995.

For participants included in the programme of the symposium, the organizing committee will provide accommodation and food in Pushchino and transfer Moscow - Pushchino - Moscow.
